

# **IDIS REQUIREMENTS – DAYLILY OR IRIS NEW CULTIVAR ACQUISITION PROGRAM**

*(amended by the IDIS Board of Directors on March 21, 2010,  
and passed by the membership on April 6, 2010)*

## **To be a host grower, a member must:**

- be a paid member of IDIS for at least **one** year prior to the scheduled plant drawing. (**Dues must be current prior to the day of the drawing.**)
- have attended a minimum of two meetings the previous year (March – August); *Pitch-In/Plant Exchange and Banquet not included.*
- have participated in one of the following: IDIS Show or Sale; worked 4 hours at Holliday Park; or served as a Chairperson or Board member the previous year. (***amended March 21, 2010.***)
- be present at the plant drawing to select host growers.
- Only one host grower per household will be allowed (***one plant per household***), with the exception noted below for AHS and AIS members\*\*.
- Plant exchanges are permitted only at the time of the drawing.
- If a host grower leaves IDIS during the growing period, return of the plants is expected.

*(Note: Host grower grows the daylily/iris in his/her garden for daylily three (3) years; iris two (2) years. At the end of that time, he/she returns any daylily increase over two (2) fans or any iris increase over one (1) rhizome, to be auctioned to IDIS members at either the September “NCAP Daylily Auction” or the August “NCAP Iris Auction”.)*

*If the member fails to return the plant at the time of the auction on two separate occasions of the same plant (iris or daylily), he/she will be put on probation and not allowed to receive another of the same plant (iris or daylily) for 2 years. Exceptions will be made for losses beyond the host’s control if and only if the host notifies the NCAP Chairperson as soon as the loss is realized, but at least one month prior to the scheduled auction. Substitution of a plant of similar quality and cost is a possible remedy at the discretion of the NCAP Chair. (amended March 21, 2010.)*

**\*\*First Drawing:** IDIS members’ names, who are also paid members of the \*AHS or \*AIS (**must be a paid member prior to the beginning of the meeting at which the drawing is held**), one plant per household.

**\*\*Second Drawing:** If there are daylilies/irises left to be distributed, any spouses, etc., under \*AHS or \*AIS “dual” membership (**must be a paid member prior to the beginning of the meeting at which the drawing is held**) who did not receive a daylily/iris during the first drawing.

**\*\*Third Drawing:** If there are still daylilies/irises left to be distributed, IDIS members’ names who are not members of AHS or AIS shall be drawn (**one plant per household**).

\*If it is a Daylily distribution, must be a member of the AHS.

\*If it is an Iris distribution, must be a member of the AIS.
